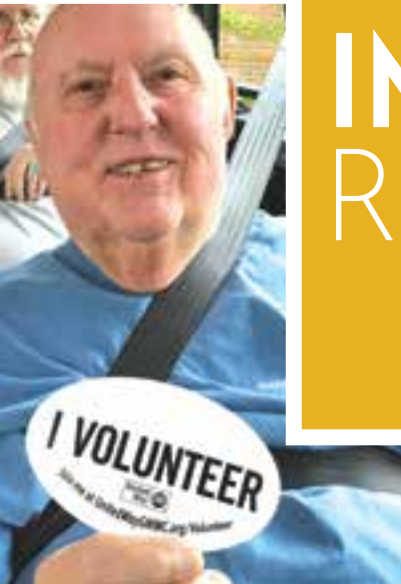

Sharing God's love and enriching lives are long standing tenets of the Luther Manor organization. This holds true today even as the world and our industry of care changes. 2017 was the first year of our three-year strategic plan. The plan is designed to adapt the organization to relevant changes, create nimble operating systems for the future and inspire a culture of community and care designed in God's image.

We included resident feedback and ideas to set priorities for continued improvement and renovations. Staff participated in employee engagement surveys and work groups to help drive employee satisfaction, retention and ultimately resident satisfaction. We added an organization-wide electronic medical records system, exceeding industry norms for utilization and implementation. We saw the completion of significant road construction that paved the way (pun intended) for landscape and signage initiatives underway this spring. Grant dollars helped pay for the implementation

of an access control system to help safeguard our campus. Therapy services were enhanced through an engagement with a nationally recognized provider and we transitioned to an outside pharmacy to help ensure our resources are focused on providing exceptional resident care. And, we set the stage for continued progress in 2018. It was a year of change and progress – grounded in our long standing tenets of sharing God's love and enriching lives.

As we continue with our plans, adjusting to internal and external forces, the Luther Manor team remains grounded in our mission and driven by our vision in support of one another, our remarkable residents and their families, and our broader community. Thank you to every staff member, each volunteer and our many donors who make our mission possible, and to the families and residents who allow us to serve. It is a pleasure and an honor.
